

**Federal Dam City Council Minutes**

**April 12<sup>th</sup>, 2010**

**Approval of Consent Agenda:** M/S/P Henderscheid, Johnson to approve following: Minutes of previous City Council Meeting, Cash Control Statement, FDSP Billing & Expense Reports, FDSP Customer Balance Summary, Approval of Claims & Payroll, Receipts and Disbursements.

**Citizen Petitions, Requests:**

A.) Citizen request for building permit.

B.) J. Nord spoke about culvert on Bog Rd. Invoice to be given to city clerk from B. Adams for dirt and labor to fix culvert.

c.) Discussion about Bog Road not being taken care of and unsafe.

**OLD BUSINESS:** C. Ross, Council Henderscheid and Mayor Ruschmeier to put up 4 stop signs (Cedar St ) and street signs. Bog Road signs to be put up. Gopher to be called for marking.

**Recycling bins:** Council Henderscheid to call for bids for cement or crushed rock under bins.

**Alleyways:** Alleyways need to be graded and filled. Alleyway between Johnson and Campbell already approved. Council Johnson and Mayor Ruschmeier to get bids on grading and fill.

**Bog Road:** Needs to be graded. Mayor Ruschmeier and Council Johnson to meet at clerk's office on Tuesday April 13<sup>th</sup> to discuss and talk to Pedersons about grading of road.

FAILURE TO OBTAIN A PERMIT WILL RESULT IN FINE AND POSSIBLE PROSECUTION.**
