Mayor has checked the lighting and has noticed that the Convenience Store does need more lighting. We will still wait for a report from the Committee.

M/S/P Resolution changing the mileage rate to the current Federal rate of 48.5 and keeping the rate at the Federal standard rate.

ALSO we were informed that Calcium Chloride would cost about 58 cents a gallon. This spraying would start sometime towards the middle of June.

City received a Fire Contract for 2007 increasing fees and defining responsibilities. Mayor Adams will discuss this with the fire department before the city accepts the terms.
