## OLD BUSINESS:

Bids for city hall work: M/S/P to get 2 bids for projects to be done in city hall. Men's bathroom, plumbing in kitchen. Discussed the water pipes in garage and trying to cover them to save on propane.

#### NEW BUSINESS:

ATT Cell tower: Shane Begley present to discuss tower project. 340' guy tower. Co-location tower. ATT has new tower in Bena 440'. 6 miles to this tower. Max is 12 miles. Shane Begley says he tried to call Verizon about co-locating on the tower that is to be built at Wakes property 2.5 miles to the south off Co. Rd 8. and they never got back to him. He says that that tower or location would not be feasible. Federal regulations govern what he can do. Environmental guidelines, dig, archeological survey, FCC, Very strict on all guidelines. Brought prop maps, showing before and after coverage, Shane Begley says they will follow Cass Co rules and ordinances for the tower. ATT tells Mr. Begley where to put the tower. They're were 3 properties, this was what they needed. Legos city property. Compound area would be fenced. Grass would be cut, etc. Once snow is gone, all studies will be done, wetland, digs, soil borings, soil types are issues, etc. Building will have generators, 12'x28' x 12' tall. Johnson feels we need to have more time to research. Hinderscheid and Tonga were in favor of tower. Johnson and Zuelow-Giffen want to table it for a couple weeks.

M/S/P Johnson, Zuelow-Giffen to table till February 28th, 2011 to get more information.
